# What is the Advanced Mobility Partnership?

- The Advanced Mobility Partnership (AMP) is a collective effort between DRCOG, Regional Transportation District, Colorado Department of Transportation and the Denver Metro Chamber of Commerce.
- These agencies collaboratively published the **Mobility Choice Blueprint** in 2019 which identified a list of tactical actions that seek to address transportation technology and new mobility options.



# Tactical action updates

- RTD implemented a **Mobility as a Service-focused pilot** funded through a Federal Transit Administration accelerating innovative mobility grant. It integrates trip planning and fare payment between multiple mobility providers using Transit App.
- RTD **Partnership Program** launched its third call for projects in Spring 2025 and awarded 8 projects funding. Since RTD launched the program in 2023, the program has funded 10 microtransit services across the Denver region.
- CDOT, in collaboration with the Autonomous Mobility Task Force, is preparing to release a new report that outlines the **development and adoption of autonomous motor vehicles**.

# Tactical action updates

- CDOT is developing the **COtransit app**, a platform to enable regional transit coordination and collaboration with transit providers that are part of the Colorado transit system.
- DRCOG launched the **Innovative Mobility Set-Aside**. The 4-year, \$4 million set-aside program awarded \$1.45 million in 2024 and conducted a second call for projects in 2025.
- DRCOG has provided technical assistance to municipalities with **shared micromobility program deployment** on data-sharing requirements and associated language for agreements.
  - Continued support for the regional shared mobility **data platform and open data dashboard**.

# Tactical action updates

- DRCOG in the fall of 2024 received a ~\$1 million [Innovative Finance and Asset Concession grant](#) from the U.S. Department of Transportation Build America Bureau to accelerate the implementation of several **bus rapid transit (BRT)** corridors.
- DRCOG awarded several set-aside projects for **microtransit planning, expansion** and **pilots** including:
  - Town of Parker Microtransit Implementation Plan (Innovative Mobility Set-Aside).
  - City of Commerce City Microtransit Study (Community-Based Transportation Planning Program Set-Aside).
  - Douglas County Transit Pilot Projects (subregional TIP).



# The AMP Working Group

- The AMP Working Group convenes virtually every other month to discuss **innovative topics** and **share information on a variety of emerging mobility topics**.
- The AMP Working Group met five times in 2025.
