Amendments to the 2026-2029 Transportation Improvement Program

Summary

May 2026 Amendments to the 2026-2029 Transportation Improvement Program, known as the TIP.

Background

The region’s transportation planning process allows for Board-approved amendments to the current TIP on an as-needed basis. Typically, these amendments involve the addition or deletion of projects, or adjustments to existing projects and do not impact funding for other projects in the Transportation Improvement Program.

The projects to be amended are included in the table and listed in the attachment. The proposed amendments to the [2026-2029 TIP](#) have been found to conform with the State Implementation Plan for Air Quality.

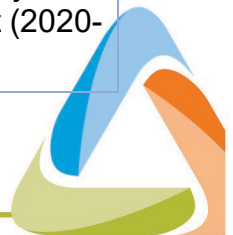

Project funding transfers:

These projects involve funding transfers from one project to another. In many cases, this might be the consolidation of funding from multiple project listings into a single listing, or the merger of adjacent similar projects that will involve a combined letting. Projects are shown below paired with the other project(s) that are part of the transfer.

For this funding transfer, funding is being transferred from multiple pools to the I270 project to consolidate funding along this corridor into a single TIP project.
