# DRCOG Climate Pollution Reduction Grant

### A Zero-Emission Building Initiative

The Denver Regional Council of Governments has been awarded \$199.7 million from the EPA's Climate Pollution Reduction Grants to **slash climate pollution** by electrifying buildings.

By 2050, the project will **cut greenhouse gas emissions from buildings by 70%**, focusing on low-income and disadvantaged communities (LIDACs). Equity isn't just part of the program; it's at its center.

The initiative will **replace fossil fuel-burning appliances** in homes and businesses and build a future-forward workforce. Together, these efforts will improve public health, spur innovation, and energize the economy.

**Created by a coalition of 58 local governments,** this effort is poised to lead the Denver Metro Area into a brighter and healthier future.


## **Highlights**

This regionwide initiative will:

- Cut 148,200,000 metric tons of CO2e by 2050 the equivalent of taking 35 million gas-powered cars off the road for a whole year.
- Support low-income and disadvantaged communities (LIDACs), exceeding the goals of the federal Justice40 initiative.
- Receive \$73 million in matched funding from local governments committed to amplifying impact.
- Train 4,800+ workers for the electrification workforce, including 1,000 upskilled workers.
- Engage 1.6 million Coloradans in electrification and decarbonization through a public awareness campaign.
- Issue 40,000+ rebates for decarbonization services and electric appliances, like heat pumps, electric water heaters, electric cooktops, and ranges.
- Significantly improve outdoor air quality in a region with high levels of air pollutants like ozone.



DRCOG brings 58 member governments together to address the region's most challenging issues.






The built environment creates 52% of the Denver Region's GHG emissions

### **Program Structure**

Four climate pollution-cutting programs:

- Free, full-service home decarbonization for LIDACs, including weatherization and upgrades.
- Free, data-driven energy advising to help residential, multifamily, and commercial building owners plan and implement upgrades.
- Rebates and incentives for electrification equipment and services.
- A Building Policy Collaborative that supports coordinated, regional policy implementation and local government capacity building.

To ensure the success of these programs, this project will undertake:

- Robust community engagement to develop programming, communications, and more.
- Comprehensive, accessible communications and public awareness campaign.
- · High-quality workforce and industry development.
