### What's an EDD?

- EDA designation
- Help lead locally-based, regionally driven economic development planning process
- Leverages public, private and nonprofit engagement to create and implement a strategic blueprint for regional collaboration
- Provides administrative and technical assistance and other resources for local communities







# How does designation occur?

- Must have an EDA-approved CEDS
- Meets EDA regional distress criteria in at least one geographical area within designated region
- Serves and represents entire geographic region






# Will this duplicate something that already exists?

- No, the CEDS has already demonstrated that this enhances current efforts.
- The following graphic underscores the difference.

### What's the cost/benefit analysis

#### **Benefits**

- Provides funding to DRCOG for staff and/or capacity
- Allows DRCOG to provide administrative and technical support to local communities
- Accesses additional data and technology resources

#### Costs

- Requires cash match (which can be inkind)
- Relatively small amount of funding
- Quarterly reports
- Annual update to CEDS



### Peer comments

- "ECCOG has been an EDD since 2009 and the benefits far outweigh the reporting requirements! Reports do take time and work but are semi-annual and annual only. Maintaining the CEDS to guide your EDD is time consuming but worth it as you qualify for many grants and funding opportunities through the CEDS and your EDD."

- "Helps leverage our work in transportation in news ways. For example, we're about to move forward with a freight study in part with EDA funds unlocked by being an EDD."

- "Being an EDD allows us to help support their work with our existing suite of programs along with the new EDA opportunities. So far, it's been received as welcome assistance, not as a duplication of efforts."

### Mid-America Regional Council

- "The designation allows us to work with economic development organizations, chambers and others."
- "MARC is often looked to for economic data and analysis, and our work on the CEDS has allowed us to integrate our regional plans with those of other regional organizations."
- "The relationships have helped us in securing EDA and other funds over the years."
- "The initial focus was on helping small communities with planning and economic development projects."
- "Now it helps connect our work around affordable housing, transportation, workforce development, and other initiatives with our economic development partners."
- "EDA's local representatives often call on us to help the applicants in strengthening their proposals."
