Summary

This item is related to selecting representatives to serve as a member or alternate on the Regional Transportation Committee, the Statewide Transportation Advisory Committee, the E-470 Board of Directors, the Advisory Committee on Aging, and the Economic Development District Advisory Committee (EDDAC).

Background

Interest was solicited for directors to serve as DRCOG's representatives on the Regional Transportation Committee, the Statewide Transportation Advisory Committee, E-470 Board of Directors, the Advisory Committee on Aging, and the Economic Development District Advisory Committee (EDDAC).

DRCOG has five seats on the Regional Transportation Committee. Three seats are reserved for the DRCOG Board Chair, Vice Chair, and the executive director. Two at-large representatives are needed as well as several alternates to serve in the event a member cannot attend a meeting.

DRCOG also has standing membership on both the Statewide Transportation Advisory Committee and E-470 Board of Directors. Each year, members are solicited to serve on behalf of DRCOG for these important regional assignments. Two DRCOG directors will be chosen to serve on either committee, one as the member and the other as the alternate.

DRCOG's Advisory Committee on Aging has openings for Board members to serve on this essential committee serving older adults throughout the region.

And lastly, in DRCOG's pursuit of federal Economic Development District designation, it is establishing an Economic Development District Advisory Committee, which will be responsible for annual updates of the region's Comprehensive Economic Development Strategy (CEDs) and will make recommendations to the DRCOG Board on technical issues and policy alternatives to ensure the CEDs accounts for the multifaceted environment that allows economic development to grow in the region. Meeting dates haven't been established yet, but most meetings will be virtual.
