TDM Services Set-aside purpose and goals.

Purpose: to support marketing, outreach and research projects that reduce single-occupant vehicle travel.

Program goals

- Reduce traffic congestion.
- Improve air quality.
- Pilot new approaches to transportation demand management.
- Support healthy and active choices.
- Improve awareness and access to mobility options for people of all ages, incomes and abilities.

Funding, criteria and process.

Funding available for 2026-2027 call:

- \$1,000,000 from 2-year set-aside.
- \$95,000 in returned funds.

Approved criteria and process:

- Review panel scored on criteria focused on vehicle miles of travel reduction, innovation and replicability.
- Staff scored data-driven elements such as short-trip opportunity zones and local match.
- Review panel discussed, ranked and recommended projects.

Review panel.

The review panel included internal and external stakeholders:

Application process overview.

Application timeline.

- **May 21, 2025:** DRCOG hosts application workshop.
- **June 6, 2025:** Letters of Intent due.
- **July 3, 2025:** Applications and Letters of Concurrence (if applicable) due.
- **July 7 – July 21:** Panel deliberation.
- **July 24:** Panel discussion and recommendations.

DRCOG received **seven** applications.

Total federal request: **\$1,034,383.**
