## Regional housing needs assessment and state compliance

## **DRCOG context**

DRCOG initiated development of a **regional housing needs assessment before state legislation** to require assessments.

- Scoping discussions and peer research, 2022-2023.
- Initiated October 2023.
- Board accepted October 2024.
- Early step on path to a regional housing strategy.





## Legislative context

- Senate Bill 24-174 requires local housing needs assessments.
  - An exception: participation in a regional housing needs assessment.
- Provides a path for state acceptance of assessments completed after January 1, 2022.
  - Submitted by December 31, 2024.
  - Conforming to state methodology.



### **Implementation context**

- Being led by **Department of Local Affairs**, or DOLA.
  - Began late summer.
  - Coordinated alongside other state legislation implementation.
- Includes engagement with:
  - Local government staff.
  - Regional entities, such as DRCOG.

#### Key dates

- November 15: State publishes final draft housing needs assessment methodology.
- Early December: DRCOG staff plan to submit for conditional approval with minor additions or clarifications through supplements in the dashboard that do not change assessment findings.
- December 31:
  - State publishes final methodologies for:
    - Housing needs assessments.
    - Displacement risk assessments.
  - Deadline for submitting already completed assessment.




## Why submit for conditional approval?

- Full conformity will require:
  - Inclusion of displacement risk assessment, but state's guidance on that step not available until December 31.
  - Procedural steps, including:
    - 60-day review period for each local jurisdiction's governing body to:
      - Hold a public meeting.
      - Submit comments to DRCOG.
    - DRCOG submission of comments to the Department of Local Affairs.
- Allow for full **confidence in content before triggering procedural steps** involving local government time and attention.
- Continue on path to a regional housing strategy.
