### Update on Planning for Burnham Yard

### Update by Piper Darlington (CTIO)

- Large property bordered by RTD and freight rail and industrial properties
- For sale in 2019, purchased in May of 2021 by CDOT
- Track alignment study started October 2022
- Noise and vibration impact to nearby neighborhoods if rail line was moved
- Been engaging with stakeholders
- Minimal operational benefit to FRPR
- Safety investments would be beneficial
- Study to give more information later this year

- Working to finalize master plan
- DOTI is considering additional planning
- How can this site help RTD's future expansion?

### Update on Regional Bus Rapid Transit Partnership

Update by Jacob Riger (DRCOG)

- Regional BRT study from 2019 served as foundation
- Corridors staged in RTP 5 to be implemented by 2030, 5 by 2040, and the rest by 2050
- Partnership is unique to this region many agencies coming together to do the work
- Partnership to help the region accelerate implementation—how do we leverage shared resources?
- More work than any single agency can do alone different agencies taking the lead on different corridors
- Designed to connect to greater rapid transit network
- Wide range of status of current projects
