### Welcome and introductions

Kay Kelly, Chair of the Advanced Mobility Partnership Executive Committee, welcomed attendees to the Advanced Mobility Partnership Executive Committee meeting.

### Tactical action updates

Emily Lindsey, Chair of the Advanced Mobility Partnership Working Group, gave an update on the Mobility Choice Blueprint tactical actions. This is an annual opportunity for partner agencies to share status updates of activities associated with tactical actions identified in the blueprint. Ms. Lindsey shared a matrix, which was updated in Spring of 2024, with the committee which highlighted current efforts underway to advance tactical actions.

### Advanced Mobility Partnership Working Group updates

Kalie Fallon, with the Denver Regional Council of Governments, gave an update on the topics discussed during the working group meetings. The working group continues to meet every other month as a forum for coordination, informational briefings and discussion on transportation technology related efforts. Since June 2024, the working

group has discussed a variety of topics including: universal basic mobility, artificial intelligence and camera technology, mobility as a service and digital ticketing, and mobility on demand.

### **Areas for coordination**

Ms. Lindsey highlighted several areas for coordination among Advanced Mobility Partnership agencies. The areas for coordination included: ongoing partnership through the regional mobility data collaborative, implementation of the Denver Regional Council of Governments' Innovative Mobility Set-Aside projects, planning and implementation of universal trip planning project/platforms currently underway in the region by the Colorado Department of Transportation and Regional Transportation District, and on current, and future, Strengthening Mobility and Revolutionizing Transportation grants.

### **Roundtable partner agency updates**

The committee discussed United States Department of Transportation discretionary grant opportunities, including the Strengthening Mobility and Revolutionizing Transportation grants. Staff from the Denver Regional Council of Governments highlighted a potential operations-focused application that could come forward from the agency and partners.
