# Multi-agency ticketing and trip planning integration efforts

#### **Colorado Department of Transportation Digital Mobility Hub Project**

- Aims to develop an easy-to-use mobile application and web platform that allows the public to plan their entire trip and pay online
- Phase one statewide GFTS project that publishes transit data to be consumed by a wide variety of apps (such as Google Maps)
- Phase two App with trip planning and universal ticketing
- Phase three expansion!
- · Testing with various agencies
- Buses first for rollout
- Benefits include: statewide program, reduction in GHG emissions, real time, mobile devices, reservations, trip planning and scheduling, universal mobile ticketing, meet requirements in SB24-032, multiple jurisdictions and agencies

• Communicating with RTD to see where they may collaborate

#### **Regional Transportation District Accelerating Innovative Mobility Project**

- Integrated trip planning and a single fare
- Different types of integration
- One app for everything don't have to switch to different apps
- Live March 1<sup>st</sup> with a two year demo period
- Complicated project
- No custom app meant faster implementation and better ongoing support
