Following the 2023 awards celebration, staff sought feedback from the Performance and Engagement Committee, executive leadership and DRCOG's senior management team.

This year, staff is securing a contract with Seawell Ballroom for a celebration on Aug. 28. Ms. Leberman provided the committee with a high-level overview of plans for the celebration, including how the Performance and Engagement Committee and Board of Directors will be involved. The Communications and Marketing team plan to refine nomination criteria and winner selection processes, finalize sponsorship levels and benefits, and begin evaluating caterers.
