SUBJECT

DRCOG's transportation planning process allows for Board-approved amendments to the current Transportation Improvement Program (TIP), taking place on an as-needed basis. Typically, these amendments involve the deletion or addition of projects or adjustments to existing projects and do not impact funding for other projects in the TIP.

The DRCOG Board conditionally approved this amendment at its January 20 meeting, dependent upon a staff finding that the new proposed project scope would have a comparable score to the original scope. After review, DRCOG staff has determined that the difference in the project's score is negligible (i.e., less than one point).

The proposed policy amendment to the <u>2016-2021 Transportation Improvement</u> <u>Program</u> has been found to conform with the State Implementation Plan for Air Quality.


