Colorado Department of Transportation Region 4 "4P" Results

- Held May-June 2023
- Purpose is to gain a common understanding of the transportation needs from varying stakeholder perspectives
- Feedback related to highways/interstates
- Online survey before meetings to hear what stakeholders wanted to discuss
- Participants included: elected officials, school districts, cities/towns/counties, RTP, local citizens
- Participants shared safety concerns, pavement conditions concerns, accessibility concerns, main street or school access concerns, emergency services needs
- Online survey received 83 responses for those unable to attend meetings
- 331 comments total (101 in DRCOG area)
- #1 concern was congestion in DRCOG area
- Pavement condition was the #1 concern in Region 4 overall
- CDOT will begin the 2050 Statewide and Regional Transportation Plans Update in 2024
