Metro Vision 2040 Update- Economic Vitality

Staff provided CAC members with an overview of stakeholder input on the topic of economic vitality including an update on the Regional Economic Strategy. Staff asked CAC members to provide feedback concerning what economic resiliency looks like now and what it will look like in 2040, CAC members had the following feedback:
