Call to Order

Chair Debra Baskett called the meeting to order at 1:30 p.m.

Public Comments

Bryce Matthews, Town of Parker, spoke in support of his jurisdiction's STAMP/UC application (Downtown Parker Urban Center Parking Implementation Strategic Plan).

Summary of August 24, 2015 Meeting

The meeting summary was accepted. Janice Finch requested clarification of the Tip Waiting List Protocol (page 3 of summary) as to whether studies on the list would be eligible if only STP-Metro funds were available; and if so, would bicycle/pedestrian projects further down the list even be reached. Steve Cook said, as proposed and approved last month, it is only for assigned funding categories; i.e., if a bicycle/pedestrian project, it would only be eligible for additional CMAQ and TAP, not additional STP-Metro funds.

ACTION ITEMS

<u>Discussion of proposed amendments to the 2040 Fiscally Constrained Regional Transportation Plan</u> for air quality conformity modeling.

Jacob Riger presented the proposed 2015 Cycle 2 amendments to the 2040 RTP, which are primarily modifications to projects already in the 2040 RTP.

The committee was asked to recommend including the proposed amendments in the transportation networks for air quality conformity modeling. After modeling is completed, the amendments will come back to the committee for a recommendation. A public hearing is expected to be held in early 2016.

Bob Manwaring MOVED to recommend to the Regional Transportation Committee the proposed amendments to the *2040 Fiscally Constrained Regional Transportation Plan* for air quality conformity modeling. The motion was seconded and passed unanimously.

<u>Discussion on project recommendations for FYs 2016-2017 studies funded through the Station Area</u> Master Plans/Urban Center Planning Studies set-aside program of the 2016-2021 Transportation Improvement Program (TIP).

Derrick Webb presented recommendations made by the STAMP/UC Project Review Panel. Staff received 17 applications through a call for projects for a total request of ~\$2.6 million in federal CMAQ funding.

Of the 17 applications, 7 projects were recommended by the STAMPS/UC Panel for a total of \$1.15 million of the \$1.2 million amount available. An administrative flat rate fee of ~\$5,900 per study will be charged by RTD.

There was discussion on whether large jurisdictions' applications overshadow small jurisdictions' applications. There were suggestions to reflect jurisdiction size in next project selection criteria and for DRCOG to provide more application assistance for smaller jurisdictions.

Janice Finch said City and County of Denver requested to revise the funding year of the National Western Center project to FY2016, rather than FY2017 as noted in the agenda attachment. Staff said this revision would be acceptable.

George Gerstle MOVED to recommend to the Regional Transportation Committee the project recommendations for FYs 2016-2017 studies funded through the Station Area Master Plans/Urban Center Planning Studies set-aside program of the 2016-2021 Transportation Improvement Program (TIP). The motion was seconded and passed unanimously.

<u>Discussion on project recommendations for FYs 2016-2017 projects funded through the Travel Demand Management (TDM) set-aside program of the 2016-2021 Transportation Improvement Program (TIP).</u>

Melina Dempsey presented the recommendations made by the TDM Project Review Panel. Staff received 18 applications through a call for projects for a total request of \$3.24 million in federal CMAQ funding. The project applications included 5 infrastructure projects (\$1.12 million total request); and 13 non-infrastructure projects (\$2.12 million total request).

Of the 18 applications received, 11 were recommended by the TDM Panel (4 infrastructure and 7 non-infrastructure) for a total funding award of ~\$2.33 million.

Another project (36 Commuting Solutions, US 36 Casual/Dynamic Pilot Ridesharing for \$150,000) was recommended for wait-listing.

Observations made by TDM panel members:

- Steve Klausing suggested making potential sponsors attend required training from CDOT to improve quality of applications.
- Aylene McCallum felt there are many constraints on applying; i.e., reporting requirements
 are too onerous considering the amounts funded are relatively small. Need to improve
 quality of applications. Dave Baskett said new federal regulations for project compliance will
 be even more stringent.

George Gerstle MOVED to recommend to the Regional Transportation Committee the project recommendations for FY 2016 and 2017 projects funded through the Travel Demand Management (TDM) set-aside program of the 2016-2021 Transportation Improvement Program (TIP). The motion was seconded and passed unanimously.

INFORMATIONAL ITEMS

Summary of draft 2014 Annual Report on Roadway Traffic Congestion in the Denver Region.

Robert Spotts reviewed the draft annual report on congestion in the Denver region. The report contains information on VMT, performance measures, locations of congestion, multimodal strategies, and recent projects. This year's report highlights a comparison of Denver area with other metro areas.

Comments:

Mike Salisbury asked if congestion pricing was considered and the future role it may play.
 Steve Cook noted this strategy is listed in the Congestion Toolkit report, but an in-depth rigorous analysis has not been done. It was pointed out that the US-36/I-25 Express Lanes are examples of congestion pricing.

- George Gerstle suggested: 1.) showing the alternative choices people have to bypass congestion, and 2.) showing historic data to see how things have changed.
- Ted Heyd asked if ridership for new RTD lines and emerging trends, such as driverless cars, are factored in. Steve Cook said fiscally constrained RTD aspects and millennial trends are factored in, but driverless/connected cars are not in the model.
- Bryan Weimer was concerned that land use model and congestion models were not integrated well.
- Janice Finch asked how the information can drive the region's investment decision-making. Can the high congested locations map be translated into some investment recommendations; i.e., investing in Traffic Signal or ITS, rather than capacity). Robert Spotts noted congestion is a factor in several areas of TIP scoring.
- Paul Jesaitis said Figure 2 contains no data on the bottleneck information. Perhaps staff could tabulate the worst intersections. Steve Cook noted the report is intended as a high-level, not engineering level, informational report.

PROPOSED ACTION/RECOMMENDATIONS

Staff recommends approval of the North Capitol Hill/Colfax Urban Center study submitted by the City and County of Denver.

ACTION BY OTHERS

April 15, 2015 DRCOG Board approved the STAMP/UC set-aside process for fiscal years 2016 and 2017.

October 21, 2015 DRCOG Board approved seven STAMP/UC studies (FY16 and FY17) and directed staff to allocate the remaining \$50,000 from this cycle.

SUMMARY

In October, the DRCOG Board approved funding seven studies totaling \$1,150,000 in federal funds, leaving an unallocated amount of \$50,000 in federal funds. The Board further directed staff to offer the remaining funds to applicants that applied for but did not receive funds during the original allocation. Staff reached out to all applicants to confirm interest in being considered for selection given the following stipulations:

- The scope of the project as originally submitted must be completed in full. Any funding gaps must be made up by the entity accepting the funds.
- The selected study will be programmed in FY17.

DRCOG staff then reconvened the Project Selection Panel to determine a final ranking of the remaining unfunded projects (shown in Attachment 1) and to award the \$50,000. The cities of Centennial and Louisville asked that their projects be removed from consideration as the Panel was determining a final ranking.

The \$50,000 was first offered to the panel's highest ranked project (Broomfield), which declined. The second-highest ranked project (Denver) accepted the funds for the North Capitol Hill/Colfax Urban Center study. Denver originally requested \$200,000 in federal funds to support the development of the study, but has agreed to complete the original scope as detailed in its application using the \$50,000 remaining in the FY16-17 set-aside.

SUMMARY

DRCOG staff has made significant progress in preparing the new MVRTP. This month we will kick-off a series of discussions with TAC to receive input on draft components. The first discussion item is the preliminary draft of the Freight and Goods Movement component (Attachment 1).

This preliminary draft provides much more information than the freight section of the 2035 MVRTP. Freight and goods movement is receiving greater emphasis at both the federal and state level and it is anticipated this component will evolve to become a Regional Freight Movement Study, a task in DRCOG's 2016-2017 Unified Planning Work Program.

DRCOG staff has worked closely with CDOT in preparing this preliminary draft. For example, the document uses CDOT's freight movement data for consistency. Staff are also participating on the statewide Freight Advisory Council (FAC) convened by CDOT, and will be seeking the FAC's review and input on a revised draft in early 2016.

DRCOG staff will provide an overview of the preliminary draft of the Freight and Goods Movement component at the November TAC meeting and seek TAC input to further revise the document.

SUMMARY

Earlier this year, the TAC was notified DRCOG would begin working with bicycle stakeholders and local government staff on a review and update of the Regional Bicycle Corridor System Vision, as depicted in Figure 7 of the 2040 RTP (attached). The system represents key regional and community corridors of an envisioned regional bicycle system. Some of the corridors are existing facilities (e.g., Boulder Creek Path, C-470 Trail, Montview Boulevard bike lanes, etc.), while other corridors will require new facilities or major upgrades to existing facilities.

The first edition of a Regional Bicycle Corridor System Vision was established in 1998. As a reminder, regional bicycle corridors are somewhat like our interstate highways and regional arterials for automobile travel. They will represent a network of key facilities bicyclists can travel along to make longer trips (i.e., connecting jurisdictions and counties). There will be many hundreds of miles of additional local facilities, not shown on the network, that still provide important connections within communities.

Staff held more than ten meetings across the region this year to obtain input on corridors to update the map to be included in the new MVRTP. In the meetings, staff provided maps showing the existing corridor system vision and added rapid transit stations, transit hubs, and designated Urban Centers to help guide the input. Through the meetings, many more miles were suggested to be added to the current system.

DRCOG staff analyzed the working maps and developed a preliminary draft regional bicycle network vision map (Attachment 2) for discussion. When deciding which corridors to include, staff considered connectivity to key destinations or activity centers, such as:

- designated Urban Centers
- o transit stations and park-n-Ride transit hubs
- colleges and universities
- o major employment, shopping, recreation and entertainment areas
- o downtowns of small cities and rural communities

Additionally, staff recommends eliminating the Community Corridors category and combining the majority of those corridors into the Regional Corridors category.

At the TAC meeting, staff will provide additional details on the preliminary draft regional bicycle network vision map. The existing system identifies approximately 1,640 miles of corridors and the proposed network would include approximately 1,360 miles of facilities. Other maps depicting the compilation of stakeholder proposals received earlier this year will also be shown. Staff desires TAC's initial thoughts regarding the proposed network.

Staff plans to solicit additional comments from stakeholders and the TAC through December 31 and bring the network back to TAC in early 2016 for further action.




