#### 1. Welcome

Paul Ballard welcomed attendees to the meeting of the Advanced Mobility Partnership (AMP) Executive Committee and began the meeting.

## 2. AMP Working Group Report

Brian Welch provided an overview of the varied topics that the AMP Working Group has worked on and discussed at their meetings over the last six months. Mr. Welch highlighted the importance of implementing Mobility Choice Blueprint as a coordinated effort and continuing to collaborate on opportunities in the region.

## 3. AMP Next Steps

Ms. Lindsey provided an overview of the Steering Committee and planning process and introduced the three focus area Steering Committees (Data and Data Sharing, Shared Mobility and System Operations).

Ms. Lindsey posed several questions for discussion and highlighted the work Steering Committees











had done discussing potential risks and opportunities before developing the recommendations in front of the committee.

Sophie Shulman noted her support for the foundational items, including many coordination and planning efforts that are critical to outline prior to implementation. She encouraged staff to be clear with the Executive Committee as costs were identified for specific projects so that funding and cost-sharing could be considered. Douglas W. Rex noted his support for the items as outlined, and encouraged staff to continue to think through the value to stakeholders and partner agencies as foundational work begins. Mr. Ballard thanked staff and partner agencies for supporting these efforts.

Mr. Rex made a motion to move forward with the next steps as outlined in the AMP Next Steps document, and as presented. Ms. Shulman seconded the motion. The motion passed unanimously.

#### 4. AMP Website

Ms. Lindsey provided a brief update on the AMP website, which was developed by DRCOG. DRCOG will host and maintain the site, while welcoming updates and resources from any of the partner agencies. Ms. Lindsey noted this was the soft launch of the site and encouraged partner agencies to share the link with their communications teams and provide feedback or suggested updates in the coming weeks.

## 5. Other Matters/Update(s)

Mr. Ballard inquired if any members had updates they wished to share with the group. Mr. Rex shared news regarding DRCOG's Regional Transportation Operations and Technology Set-Aside project recommendations, including many projects relevant to AMP tactical actions. Mr. Rex also thanked Mr. Ballard for serving as the Chair, and thanked him for his role at RTD as leadership transitions from interim to permanent.
