Meeting Summary

1. Welcome and Introductions

Emily Lindsey, Chair, welcomed attendees to the Advanced Mobility Partnership (AMP) Working Group.

2. Strengthening Mobility And Revolutionizing Transportation Grant Discussion

Emily Lindsey, DRCOG, gave an overview of the Federal 2023 Strengthening Mobility and Revolutionizing Transportation (SMART) grant opportunity. In order to promote transparency and coordination across the region, the Denver Regional Council of Governments is collecting letters of interest from agencies in the Denver region who will be submitting a SMART grant application. The letters of interest will be submitted to the Transportation Advisory Council for review and discussion at the September 25, 2023 meeting. Letters of interest forms are due September 14, 2023. The Denver Regional Council of Governments will provide letters of support to projects consistent with the 2050 Metro Vision Regional Transportation Plan.

Jacob Riger, DRCOG, gave an overview on the Denver Regional Council of Governments SMART grant proposal. The council's application is for a Human Services Transportation Trip Exchange Hub, which will allow human services transportation providers to coordinate and exchange data to find the most efficient processes for providers and users. There were no other grant applications from other agencies discussed.

3. Informational Briefings

Regional Transportation Operations and Technology Set-Aside Projects

Greg MacKinnon, DRCOG, gave an overview of the Regional Transportation Operations and Technology Set-Aside project applications received by DRCOG for fiscal year 24-27 as well as an overview of the evaluation panel results and recommendations. There were 19 applications submitted for a total of over \$19 million. Applications were submitted by the City of Aurora, City of Boulder, Castle

Rock, CDOT, City of Denver, University of Colorado Denver, Jefferson County, City of Littleton, City of Longmont, City of Louisville, RTD, Superior and City of Thornton. Based on scoring criteria, the evaluation panel made recommendations for funding 13 projects at a total cost of just under \$11 million. Projects either received full or partial funding recommendations.

Connected Vehicle Project Updates

Heather Pickering-Hilgers, CDOT, gave an update on the Colorado Department of Transportation's Connected Vehicle project. The Connected Vehicle program was started in 2015. In 2019, the project moved to an internal cloud-based system, which expanded the project's capability and efficiency. The Connected Vehicle Operational Data Environment performs data ingestion, transformation, analysis, security, broker and device management and connects into other data systems such as the Advanced Traffic Management System and Real Time Data Hub.

The Connective Vehicle Manager Tool quickly displays real time information, including a heat map of data types, message counts and roadside unit status and connectivity. Current use cases for the tool include communicating construction worker presence out on the roadway, events to detect harsh breaking and spot weather and traffic signal priority for snowplow operation. Past projects include I-70 mountain corridor deployment, Region 1 connected snowplow signal priority and federal discretionary grants from the United States Department of Transportation. Future projects include an onboarding unit refresh on the I-70 mountain corridor and curve speed warning on Wolf Creek Pass.
