### SUMMARY FINANCE AND BUDGET COMMITTEE MEETING Wednesday October 18, 2023

Chair Whitlow called the meeting to order at 5:34 p.m. with a quorum present.

### Move to Adopt the Consent Agenda

Director Williams **moved** to adopt the consent agenda. The motion was **seconded** and **passed** unanimously.

Items on the consent agenda included:

• Summary of the September 20, 2023 Meeting

Discussion of a resolution authorizing the Executive Director to execute a contract with Consumer Direct Care Network inclusive of a \$95.00 monthly fee per enrolled participant for a two year-term commencing January 1, 2024 with three one-year options to renew upon satisfactory performance.

Jayla Sanchez-Warren provided an overview of the contract to the members. In March 2016, the AAA began to offer self-directed care to veterans referred by the Veterans Health Administration and the VA Eastern Colorado Healthcare System as participants of Veteran Directed Care. The purpose of the program is to provide support to disabled veterans who wish to remain living in their homes with dignity and quality of life. A Request for Proposals (RFP) was published in August 2023 to solicit proposals from Financial Management Services (FMS) providers to deliver fiscal/employer agent services for the program's enrolled veterans. Staff selected Consumer Direct Care Network due to their extensive experience in directing FMS programs, the number of highly qualified staff that can be dedicated to the program, their robust web portal that will serve veterans, and their competitive pricing plan. Staff anticipates the number of veterans enrolled in this program to be more than 115 at the time of contract commencement.

Director Mulvey **moved** to adopt <u>Resolution No. 38, 2023</u>, authorizing the Executive Director to execute a contract with Consumer Direct Care Network inclusive of a \$95.00 monthly fee per enrolled participant for a two year-term commencing January 1, 2024 with three one-year options to renew upon satisfactory performance. The motion was **seconded** and **passed** unanimously. Discussion of a resolution authorizing the Executive Director to accept funds from the Colorado Department of Local Affairs, Colorado's Energy and Mineral Impact Assistance Fund, in the amount of \$125,000 for a one-year term to support the development of a regional housing needs assessment.

Sheila Lynch provided a brief overview of the fund distributions to the members. On October 6, 2023, the Department of Local Affairs (DOLA) informed DRCOG that the application to the More Housing Now Set Aside of the EIAF for \$125,000 to support the development of a regional housing needs assessment was awarded. The purpose of the funds is to assist political subdivisions that are socially and/or economically impacted by the development, processing, or energy conversion of minerals and mineral fuels with planning and analysis to address barriers to the development of affordable housing in their communities. The EIAF funding requires a 50% match. This funding will be aligned with Metropolitan Transportation Planning funding through the Unified Planning Work Program (UPWP) to support the development of a regional housing needs assessment.

Director Williams **moved** to adopt <u>Resolution No. 39, 2023</u>, authorizing the Executive Director to accept funds from the Colorado Department of Local Affairs, Colorado's Energy and Mineral Impact Assistance Fund, in the amount of \$125,000 for a one-year term to support the development of a regional housing needs assessment. The motion was **seconded** and **passed** unanimously.

ED Rex informed the members that DRCOG's annual audit has been completed and the results of the audit will be presented at their November meeting. He thanked Jenny Dock and her staff for all their hard work during the audit.

DRCOG last undertook a major website refresh more than seven years ago, and Finance and Budget Committee approved negotiating a contract with Gravity Works to redevelop and redesign all web properties on August 17, 2022. At the June 21, 2023 Finance and Budget Committee meeting the executive director was authorized to extend the contract to December 31, 2023 due to delays in completion of foundational tasks, including stakeholder engagement. Further delays have occurred related to ensuring we meet accessibility requirements, along with finalization of site design, and estimated completion date is now March 31, 2024. This request does not seek any increase in funding, and this project is included in our approved budget.

### SUMMARY

DRCOG facilitated a Request for Proposal (RFP) process for the Regional Housing Needs Assessment (RHNA) in July 2023 to identify a consultant team to lead the twophase process of the RHNA. The Finance and Budget committee adopted a resolution on August 24, 2023 authorizing the Executive Director to negotiate a contract with the consultant for the first phase of the RHNA and DRCOG entered into a contract with ECONorthwest in September 2023 for the first phase at \$125,000.

Since entering into the contract, DRCOG has received a revenue contract from the Department of Local Affairs (DOLA)'s More Housing Now Initiative set aside program through the Energy and Mineral Impact Fund for \$125,000 to support the second phase of the RHNA.

DRCOG staff recommend that the Finance and Budget Committee authorize the Executive Director to negotiate and execute a revised contract with ECONorthwest, for Phase One and Phase Two of the RHNA. The total contract amount is not to exceed \$250,000 and the contract term will be one year.

### PREVIOUS DISCUSSIONS/ACTIONS

<u>August 24, 2023</u> – Finance and Budget Committee approved a contract with ECONorthwest for Phase 1.

<u>October 18, 2023</u> – Finance and Budget Committee approved funds be accepted from DOLA.

### SUMMARY

The *Articles of Association* state that "The Nominating Committee shall be appointed in November of each year and consist of member representatives herein designated: The Immediate Past Chair of the Board (or the Vice Chair if there is no Immediate Past Chair); one Board member representing the City and County of Denver; one member selected by the Performance & Engagement Committee ...; one member selected by the Board; and one member selected by the Board Chair." If more than one member expresses interest in serving, a ballot vote will be taken to select the Nominating Committee member.

At the January meeting each year, the Nominating Committee shall present to the Board nominations for Executive Committee members to be elected at the February meeting.

The Board has established the following guidelines to assist in selection of members of the Nominating Committee:

- Members of the Nominating Committee are not eligible to be nominated for a position on the Executive Committee (Board Officer) by the committee or from the floor.
- Members of the Nominating Committee shall have served not less than one year on the Board before being eligible to serve on the Nominating Committee.
- A designated alternate may not serve on the Nominating Committee.
- In the appointment of the Nominating Committee, consideration shall be given to providing representation of a broad cross-section of the Board, taking into account community size, geographic location, the rate of growth, county and municipality, rural and suburban and other factors.

### SUMMARY

DRCOG has been facilitating regional data acquisition projects on behalf of member governments and regional partners since 2002. These parties requested that DRCOG coordinate the acquisition of imagery and related products during the 2024/25 project cycle. To accommodate this effort, DRCOG has pursued the following actions.

- determined that Sanborn and Nearmap (both selected through a competitive RFP process in 2021), are eligible for contract renewal.
- provided customized cost quotes to potential partners in April 2023 to coincide with the beginning of their annual budget processes.
- began collecting partner funding commitments in October 2023.

Sanborn has served as DRCOG's aerial imagery acquisition vendor since 2016. Sanborn provides a custom imagery product that is acquired and processed to our specifications once every project cycle. DRCOG staff recommends negotiating and executing a new contract with Sanborn for an amount not to exceed \$750,000.

In addition to imagery captured every two years, a subset of DRCOG's partners also require data captured and delivered more frequently. Nearmap provides imagery and related products and services twice a year as an off-the-shelf, supplemental solution. As part of the 24/25 imagery cycle, DRCOG staff further recommends negotiating and executing a contract with Nearmap for an amount not to exceed \$450,000.

The procurement of imagery and related products and services will be funded by project partners, including member governments and regional, public entities like water utilities and RTD.
