Chair Colleen Whitlow called the meeting to order at 5:30 p.m. with a quorum present.

Move to approve consent agenda

Director Levy **moved** to approve the consent agenda. The motion was **seconded** and **passed** unanimously.

Items on the consent agenda included:

• Summary of the November 15, 2023 meeting.

Discussion of a resolution authorizing the Executive Director to allocate additional federal and state funds to AAA contractors totaling approximately \$1,600,000 for the state fiscal year ending on June 30, 2024.

Sharon Day provided an overview of the funding allocations to the members. DRCOG informed AAA contractors of the opportunity to request additional funds to support their programs. Two-thirds of contractors responded with requests totaling approximately \$3.2 million. The requests outlined the projected additional service units and consumers they will be able to serve, together with explanations for needing the additional funds. The ACA funding subcommittee reviewed the requests and have made recommendations based on available funding of approximately \$1.6 million. Funds allocated must be fully expended by the end of the state fiscal year ending on June 30, 2024.

Director Mulvey **moved** to approve **Resolution Number 45, 2023,** authorizing the Executive Director to allocate additional federal and state funds to AAA contractors totaling approximately \$1,600,000 for the state fiscal year ending on June 30, 2024. The motion was **seconded** and **passed** unanimously.

Discussion of a resolution authorizing the Executive Director to negotiate and execute contracts for approximately \$200,000 to projects allocated Human Services Transportation Set-aside funding beginning January 1, 2024 and ending December 31, 2024.

Travis Noon provided a summary of the contracts to the directors. DRCOG released a call for projects in Fall 2022 for the Human Services Transportation, Federal Transit Administration Section 5310, and Older Americans Act/State Funding for Services

funds for transit projects in the region. DRCOG received proposals from 16 agencies requesting over \$10 million in transit funding. There was approximately \$8 million available between the 3 funding sources. DRCOG will award approximately \$200,000 to projects from this call.

DRCOG staff has worked to figure out a solution to honor the projects that were approved by the Board. The 2024 Human Services Transportation funding will be a combination of Congestion Mitigation and Air Quality funding as well as Multimodal Transportation and Mitigation Options Fund money.

Director Williams **moved** to approve **Resolution Number 46, 2023**, authorizing the Executive Director to negotiate and execute contracts for approximately \$200,000 to projects allocated Human Services Transportation Set-aside funding beginning January 1, 2024 and ending December 31, 2024. The motion was **seconded** and **passed** unanimously.

Summary

Background

DRCOG is currently under contract with Felsburg, Holt and Ullevig for the Alameda Corridor Study. The current contract (EX23021) runs from June 27, 2023 through May 31, 2024. The total value of the contract is \$297,000.00.

Staff would like to extend this contract through November 30, 2024. There is no anticipated change in the scope of work associated with this contract extension. The extension is to ensure the project team has sufficient time to wrap up the project, thoroughly review all deliverables, and ensure the final product complies with Colorado's accessibility requirements. It took slightly longer than originally anticipated to initiate the project after the contract was signed in 2023, and given the increased focus on accessibility, staff want to ensure adequate time for all deliverables to be fully compliant.

Summary

This action is related to the current (2023-24) year grant funding from the Governor's Office to provide regional grant navigation services for the Infrastructure Investment and Jobs Act and Inflation Reduction Act grant opportunities for local governments.

Background

The bi-partisan Infrastructure Investment and Jobs Act of 2021 commonly referred to as the IIJA, provides for approximately \$1.2 trillion in federal funds for investment in infrastructure and job creation, including approximately 70 programs with funding available to local governments in Colorado. The Colorado Office of Economic Development and International Trade, better known as OEDIT, originally provided funding that would allow DRCOG to contract for IIJA grant navigation services through the end of 2023. The state extended that period to run for a full year, or whenever funds have been completely expended, beginning with the start of services by EST, Inc. on April 15, 2023. EST Inc, was selected through a competitive RFP process and contracted to provide IIJA regional grant navigation services through December 31, 2023 and that contract was extended to run through April 15, 2024. EST, Inc. has since merged with WSB Engineering and will henceforth be referred to as WSB. The Governor's Office has made an additional year of funding available to continue the existing program from the beginning of the new contract, which will begin upon the complete expenditures in the current contract and anticipated to be March 1, 2024 through February 28, 2025.

Background

In December 2023, DRCOG released a Request for Proposals to solicit proposals from planning consulting firms qualified and experienced in developing active transportation plans. The purpose of the regional Active Transportation Plan is to evaluate the existing regional active transportation network programs, policies, practices and partnerships, and identify recommended actions and activities to support active transportation in the Denver region.

DRCOG received three proposals in response to the Request for Proposals which were reviewed and evaluated by a consultant selection committee. The panel included subject matter experts from DRCOG's Transportation Planning and Operations division and Regional Planning and Development division as well as representatives from the Administration and Finance division.

The consultant selection committee unanimously recommends the Finance and Budget Committee authorize the Executive Director to negotiate and execute a contract with the preferred consultant, Nelson\Nygaard. The total contract amount is not to exceed \$350,000, for a term not more than 24 months from the date of contract execution. This work activity and funds have been allocated to this task in DRCOG's FY 2024-2025 Unified Planning Work Program.

Summary

A request to authorize the Executive Director to negotiate and execute a contract with Fehr and Peers for the North Federal Microtransit study in an amount not to exceed \$74,525 for a term of 14-months from the date of contract execution.

Background

In October 2023 DRCOG released a Request for Proposal (RFP) to solicit services from planning firms with experience in developing small-area, transit, and mobility-service focused multimodal transportation plans, specifically focused on improving first and last mile connections to local neighborhood destinations and transit stations. The purpose of this RFP was to identify a firm to lead the planning and analysis work for the North Federal Community-Based Transportation Plan. This plan is evaluating potential microtransit or other mobility service options to serve low-income residents in the community on either side of Federal Boulevard between 50th Avenue and 80th Avenue in Westminster and unincorporated Adams County.

DRCOG received four proposals in response to the RFP which were reviewed and evaluated by a selection panel. The panel included subject matter experts from DRCOG's Transportation Planning and Operations Division, as well as staff from Westminster, Adams County and CDOT.

Based on the selection panel's evaluation, DRCOG staff recommend that the Finance and Budget Committee authorize the Executive Director to negotiate and execute a contract with the preferred consultant, Fehr and Peers. The total contract amount is not to exceed \$74,525. Federal planning funds have been allocated to this task in DRCOG's current fiscal year 2024-2025 Unified Planning Work Program. The contract term will be 14-months from the date of contract execution.

Whereas, the selected consultant has demonstrated qualifications developing small-area, transit, and mobility-service focused multimodal transportation plans, specifically focused on improving first and last mile connections to local neighborhood destinations and transit stations; and

Whereas, DRCOG has a task in its Fiscal Years 2024-2025 Unified Planning Work Program to develop community based transportation plans; and

Whereas, DRCOG has budgeted \$100,000 in federal fiscal year 2024 for the development of this community based plan and plans to spend \$25,000 of that on engagement.

Now, therefore, be it resolved that the Executive Director is authorized to negotiate and execute a contract with Fehr and Peers for the North Federal Microtransit study in an amount not to exceed \$74,525 for a term of 14-months from the date of contract execution.

Background

The Denver Regional Council of Governments' Way to Go program markets vanpooling as a commute option to help reduce traffic congestion and vehicle miles of travel in the Denver region. Vanpool riders pay a fare to ride in a vanpool, and the Regional Transportation District subsidizes these fares through the Way to Go program. The Denver Regional Council of Governments must contract with a firm to lease vans to vanpool groups, provide administrative services, and serve as the direct reporter of vanpool data to the National Transit Database (NTD). Enterprise Leasing Company of Denver, LLC was selected to provide these services through a competitive proposal process. As a result of growth in the vanpool program, the Regional Transportation District has budgeted \$583,000 for vanpool fare subsidies in 2024, and the program is expected to grow more over the next three years. This action will permit the Denver Regional Council of Governments to accommodate this growth and continue subsidizing vanpool fares and operating a vanpool program under the Way to Go brand by contracting with Enterprise Leasing Company of Denver, LLC.

Summary

This action is related to the Area Agency on Aging Choice Services Transportation program is seeking to contract trip scheduling calls with Charitable Rides and Adult Services, LLC doing business as OnTheGo.

Background

The transportation program receives approximately 646 calls per month for trip scheduling requests and an additional 239 calls for new persons interested in transportation. Due to high call volumes, callers must leave a voicemail and wait up to 48 hours before receiving a call back. This results in frequent phone tag, increases barriers to accessing transportation, prevents an on-demand transportation model, and increases client and staff time spent on trip coordination.

The Area Agency on Aging explored many paths and determined a call center to manage trip scheduling services was the best option. A call center improves equity among transportation services by allowing non-smartphone users to obtain on-demand trips through providers like Uber. Historically, clients with limited knowledge of technology or those who do not have access to smartphones are limited to scheduling rides significantly in advance which increases the number of missed rides and program costs. A transition to a call center will allow the Area Agency on Aging to provide live customer support to new callers needing transportation, trip troubleshooting support, and any other transportation needs callers may have. Additionally, staff will have increased capacity to explore other program enhancements including the recently launched pilot for emergency rides.

A Request for Proposals was published in November 2023 to solicit proposals for a call center to provide trip scheduling services for two of the Area Agency on Aging's contracted transportation providers. Five vendors responded and three vendors were selected for interview and evaluation by DRCOG staff. The interview committee selected OnTheGo due to their experience managing transportation programs for other Area Agencies

on Aging, their robust software containing many ideal capabilities for trip coordination and monitoring, and their customer service success rate.

The Area Agency on Aging anticipates this change will allow the program to transform into a more on-demand transportation model a highly requested service among 60+ constituents, reduce costs on canceled/missed rides, and enhance client experience and support provided.
