Call to Order

Karie Erickson Committee Chair called the meeting to order at 11:02 a.m.

Public Comment Period (Non-ACA Members)

Allison Cutting from Douglas County told the committee Douglas County planned to have an older adult town hall On February 29th in Castle Rock. They will be discussing

the outcome of their older adult initiative. They would like to have as many people attend as possible. Start time will be 4 30 p.m. and will be in person and online.

Report of the Chair – Karie Erickson

- Chair Erickson remarked about the beautiful celebration of life that was held for ACA member and former Centennial Mayor Cathy Noon. Cathy was beloved by many and will always be with the ACA in spirit. Members have all learned a lot from her guidance and leadership and her caring heart.
- Chair Erickson found out about a transportation company called Med Ride. They
 serve the entire State of Colorado and employ 300 staff. They have 250 vehicles
 with cameras inside and outside of the vehicles and have door through door service.
 Chair Erickson thought they would be good for short trips but would be cost
 prohibitive for longer trips.

Report of the AAA Director – Jayla Sanchez-Warren

- Jayla provided a short tribute to Cathy Noon. She shared pictures of Cathy through the years and said how lucky we were to have known her, worked with her, and laughed with her. She will be missed.
- Jayla had a meeting with TF and Associates, the consultant hired to help the AAA develop partnerships with hospitals and insurance companies.
 - Accomplishments so far are:
 - The consultant did a workforce and provider capacity analysis.
 - ° Reviewed opportunities in the market.
 - Reviewed the AAA operational elements that might need to be adjusted should the AAA partner in this space.
 - Developed a pay and outreach plan, the goal is to generate more funding for services.
 - TF and Associates initial findings and recommendations are for the AAA to keep doing more of what they are doing now and to get paid for services.
- Jayla met with Kristine Burrows, the new Senior Specialist on Aging at the Department of Human Services. Kristine has worked at Jewish Family Services, Next 50 and Easter Seals.
 - Kristine is working on a strategic plan on aging for the State.
 - Jayla and Kristine discussed the needs and challenges in the region and in the State as identified in the CASOA report.
 - They discussed public and private partnerships.
 - The new regulations that will be coming from the Administration on Community Living (ACL) will change the way the AAA does their work, and they talked about how they will accomplish the changes without more funding.
- Jayla, Doug Rex, DRCOG Executive Director, Ron Papsdorf, Director of Transportation and Sheila Lynch, Director of Regional Planning and Development

met with Congresswoman Caraveo. They talked about what DRCOG is doing in the area of transportation, regional planning, and in the area of aging. Congresswoman Caraveo was interested in what happened with Senior Hub's meal program and how the AAA would work with Adams County and other contractors to continue the meal service that Senior Hub would no longer be providing.

- Jayla reminded the committee that the general enrollment period for Medicare Advantage Programs is underway from January through March 31st. This is the time changes can be made to the Medicare Advantage Program.
- Jayla received the semi-annual report from Nymbl, the fall prevention balance program that DRCOG helps fund. Nymbl signed up 4,154 new participants and reactivated 5,500 current enrollee's. This continues to be the largest fall prevention program in the country.

Move to approve consent agenda

Items on the consent agenda included: December 1, 2023, meeting summary.

Barbara Boyer motioned for approval. Wynne Shaw seconded the motion; the consent agenda was unanimously approved.

Informational Briefings

Legislative update - Rich Mauro

- <u>SB-040</u> the State Funding for Senior Services, is concerning the appropriation for state funding for senior services, in connection with adjusting the general fund appropriation for inflation annually and reviewing the adequacy of the appropriation every three years. This is the bill that DRCOG has been supporting through a public awareness campaign. The appropriation is for \$5 million.
 - Rich Mauro has been invited to attend a meeting with the Joint Budget Committee (JBC) to discuss this bill.
 - On January 25th Jayla along with other AAA directors, Chris Lynn from SRC, Frank Bruno from Via, and representatives from several statewide aging advocacy organizations participated in a panel to testify on the need for the additional funding. They received an eight to one vote in favor. The bill will go directly to the Appropriations Committee and will remain there until the end of the long bill process when the JBC will decide on spending.
- <u>HB24-1052</u> is the Senior Housing Income Tax Credit bill concerning the reinstatement of the income tax credit to help income-qualified seniors afford housing.
- Rich is working with DRCOG lobbyist Jennifer Castle to come up with an idea for emergency funding that would help in situations like what happened with the Senior Hub's meal program in Adams County. Rich and Jennifer worked on a proposal and

gave it to Senator Zenzinger who brought the proposal to the JBC. JBC staff are currently drafting a bill which will be a companion to the supplemental bill.

Update on public awareness campaign – Kelly Roberts

- A toolkit was sent to ACA members, Colorado AAA's, DRCOG AAA staff and a dozen community partners.
- The toolkit contains a frequently asked questions (FAQ) document, a flyer with the Project Angel Heart client story, and an editable flyer which can be customized for individual needs, and social media examples. It also contains a link to a Survey Monkey questionnaire which DRCOG would like a shared input on conversations generated by the advocacy.
- DRCOG is posting weekly on social media sites Facebook, Twitter, Instagram, and LinkedIn.
- DRCOG will keep the committee informed of changes to any legislative bills as the session progresses.

Home delivered meal program in Adams County. - Jayla Sanchez-Warren

- Before Christmas Jayla found out that Senior Hub could no longer provide home delivered meals to Adams County.
- Senior Hub delivered meals to 550 clients in Adams County. 500 of the meals were being paid for by Adams County, the remaining 50 were for the Eastern Plains and paid for by DRCOG.
- DRCOG quickly began to meet with Adams County to make sure seniors continued to receive meal delivery services.
- Adams County Commissioners stepped up by voting for \$50,000 of emergency funds to be directed to Senior Hub for the Meals on Wheels program. This covered two weeks of meals while a long-term solution could be worked out.
- Adams County partnered with Senior Hub, Volunteers of America, and DRCOG for a long-term solution. Volunteers of America prepared the meals and dropped them off at Senior Hub for volunteers to deliver.
- During this time there was a lot of media attention, the press wanted to give Adams
 County people a way to help so they asked for interested volunteers to call. At the
 same time Senior Hub closed for two weeks during the holidays.
- DRCOG became the site that people could call in to volunteer. DRCOG staff managed those calls and delivery of meals to the Eastern Plains.
- Jayla called all the Eastern Plains clients to find out their needs and how to best provide them their meals. It became clear to Jayla that DRCOG was serving the right population because these folks could not afford food or could no longer drive to go out and get food on their own.
- Because the length of delivery time to the Eastern Plains is long, keeping cold foods cold and the hot food hot enough to meet food safety requirements it was decided frozen meals would be the best option.

• On January 9th Adams County Commissioners voted to give another \$500,000 to the meal program. These funds will provide meals through May 2024.

DRCOG Board Report – DRCOG Board Chair Steve Conklin

- At their last meeting Steve Conklin, DRCOG Board Chair said the Governor's staff talked to the DRCOG Board about the land use bills. Chair Conklin said that there are some of the same concerns as last year in terms of local preemption where legislation would take away local decision making. Chair Conklin appreciated the Governor's staff coming in to update the Board, he encouraged people to think about the legislation as the process continues, and when they have conversations.
- Chair Conklin told the group that at the February meeting they will elect new officers
 to the DRCOG Board, and this was his second to last meeting as DRCOG Board
 Chair. He will continue to serve on the ACA. He said there are new folks that have
 expressed an interest in the ACA and that we would be seeing some new DRCOG
 Board members to the ACA in the near future.

County Reports

Adams County – Dawn Perez

- Adams County will be holding their combined Arapahoe and Adams County Eastern
 Plains meeting in June. The event is typically well attended by the people on the
 Eastern Plains.
- Dawn said she was sorry about the problems at Senior Hub but was delighted to hear that the County Commissioners helped out.
- Dawn announced that the Board of County Commissioners has approved a second person to represent Adams County. Greg Kaler is currently the treasurer of the Adams County Aging Network (ACAN) and will join the ACA committee at the next meeting.

Arapahoe County – Barbara Boyer

 With the loss of Cathy Noon, Arapahoe County is looking for someone to take over her position on the Arapahoe County Council on Aging (ACCoA). They will be looking at a variety of people paying attention to diversity, equity, and inclusion.

Douglas County – DRCOG Vice Chair Wynne Shaw and Gretchen Lopez

- Wynne Shaw informed the committee that the Lone Tree City Council approved a
 two-phase project of 165 affordable senior units, 101 units being built in phase one
 of the project and 64 units in phase two. Area median income (AMI) will range from
 30 to 80 with an average of a 56 AMI. The development will be located at Ridgegate
 East. There will be a process through Douglas County to get on the waitlist.
- Gretchen Lopez let the group know that the Seniors Council has been in conversation with Nymbl Science about hosting a second meeting of the Allies for Aging in mid-March in Douglas County. They are trying to draw other organizations from the Denver Metro area and Colorado Springs

Other Matters by Members

Tex Elam announced his resignation from the ACA. He said being on the committee the past 15 years has been a wonderful experience and thanked the committee for all their work. Chair Erickson said Tex was amazing as an advocate, a voice for older adults, a visionary, and a leader. She thanked him for being on the committee and said the committee has been blessed, lucky and fortunate to have him.

Senate Bill 24- 040	State Funding for Senior Services- For the 2024-25 state fiscal year, the bill appropriates \$5 million from the General Fund to the Department of Human Services for state funding for senior services. Requires the General Assembly to annually adjust for inflation the General Fund appropriation for state funding for senior services. No later than August 2024, and each August every 3 years thereafter, the bill requires the CDHS, the Office of State Planning and Budgeting, and representatives from area agencies on aging to review the adequacy of the appropriation for senior services for the prior 3 fiscal years to address the needs of older adults who request services pursuant to the "Older Coloradans' Act". CDHS is required to report the findings of the adequacy review to the General Assembly.	Danielson & Ginal/ Willford & Young	Senate Appropriations	Support	Link	The area agencies on aging (AAAs) have not received an increase in state base funding since 2018. Temporary funding received since 2019 (including excess homestead exemption dollars and pandemic relief) is coming to an end in 2024. Without an increase in funding, the AAAs will be faced with a serious fiscal cliff, as they struggle to meet 2024 demand and cost levels with 2018 budget levels. House Bill 24- 1052	Senior Housing Income Tax Credit- Reinstates a refundable income tax credit that was available for income tax year 2022, so that the credit is available for 2024. The credit is for a qualifying senior, which means a resident individual who: is 65 or older at the end of 2024; has federal adjusted gross income (AGI) less than or equal to \$75,000 if filing a single return, or less than or equal to \$150,000 if filing a joint return; and has not claimed the senior property tax exemption for the 2024 property tax year. The amount of the credit is: \$1,000 for a qualifying senior filing a single return with federal AGI that is \$25,000 or less. For every \$500 of AGI above \$25,000, the amount of the credit is reduced by \$10; \$1,000 for a qualifying senior filing a joint return with another individual who is not a qualifying senior with federal AGI that is \$50,000 or less. Background

Southwest Improvement Council serves Adams, Arapahoe, Broomfield, Denver, Douglas, and Jefferson counties. They provide Native American and Hispanic elder screening and evaluation services.

The Southwest Improvement Council offers screening and evaluation for Native American and Hispanic elders who are underserved and experiencing poverty or other challenges to maintaining dignified, independent living. Their staff provide one-on-one mentoring and monitoring of each elder. Staff screen and evaluate underserved elders for situational, emotional, physical, and financial challenges to independent living. They also screen and evaluate a client's situation to identify and provide supportive services for each elder's urgent human needs, and ensures service is provided, the client's needs are met, and the client is satisfied with all aspects of assistance and service.
