<u>Call to Order</u> The meeting was called to order at 6:30 p.m.

<u>Public Comment</u> No public comment was heard.

Metro Vision 2040 Update- Older Adults and the Boomer Bond

Staff provided CAC members with an overview of trends in older adult demographics and an introduction to DRCOG's Boomer Bond initiative. CAC members had the following feedback:

- CAC members had several questions about DRCOG's Boomer Bond
 - Is it a financial program?
 - Is DRCOG the "owner" of the program?
 - Has there been push back from communities?

-Staff explained that the Boomer Bond is a partnership, many partners helped DRCOG develop the Boomer Bond Assessment Tool, and DRCOG will roll out the assessment too. There has not been push back from communities, and in fact many communities are interested in completing the assessment.

- It's interesting that older adults in Colorado age in place rather than retiring somewhere else
- There will be less tax base from older adults in the future because there will be more demand for services
- CAC members would like additional information on naturally occurring retirement communities -DRCOG staff will send CAC members a link to an interview DRCOG's Area Agency on Aging's (AAA) Director recently gave on naturally occurring retirement communities
- There was a recent segment on NPR about the Greenhouse Retirement Community where older adults have their own private bedrooms and bathrooms in a home with other older adults, but come together for meal times
- Multigenerational living is on the rise because of the planning and market failure
- With the increase in the older adult population, there will be big impacts on the transportation system
 - \circ $\;$ The demand for Call-n-Rides, shuttle services, etc. will increase
 - o Suburban communities are lacking transit and connectivity
 - Are things like self-driving cars and sharing cars feasible?

- o Adult tricycles are being made and that could yield an increase in older adult cyclists
- Bicycle-centric communities for older adults are beginning to emerge
- o When it comes to older adults and driving, where are we drawing the line?
- o Communities with transit is very important so older adults can have their independence
- On October 20, the City of Littleton Aging Well Resource Center will be opening in the Bemis Library

Staff noted that an online version of the Boomer Bond Assessment Tool will be available in early 2015 and that DRCOG's AAA has a Network of Care website with plentiful resources for older adults.
