Call #4 (Subregional) opens **November 28**th and **\$192.3 M** is available for the DRCOG MPO. Douglas County Forum is estimated to be allocated **\$19.945 M** which is **10.37**% of the available funds for MPO. This includes **\$11.238 M** in **STBG** funds and **\$8.707 M** in **AQ/MMOF** funds.

Call #4 Waiting List – Projects not selected for funding will be added to a DRCOG Wait List

Call #4 Applications - Individual projects should be submitted using **1** of the following tracks:

- AQ/MMOF Track (Majority of AQ/MMOF funds are in 2026 and 2027)
- STGB Track (STBG funds are distributed over 2024, 2025, 2026 and 2027)

Note: Individual transit, bike and / or pedestrian projects can be submitted using either track

- DC, Colorado over C-470 Bike/Ped Bridge (preconstruction) \$500 K request (\$650 K total)
- DC, Integrated Transit / Multi-Modal 2–3-year Pilot Project(s) \$2.5 M request (\$2.9 M total)
- LT, Lincoln Avenue Multi-Modal Connectivity Early Action Project \$5 M to \$7 M request (\$12 M total)

Recently Identified Potential STBG Track Call #4 Projects - \$11.2 M available / \$21.2 M requests

- **CR**, Crystal Valley Interchange \$8 M to \$11 M request (\$80 M total)
- **CP**, Happy Canyon Interchange (preconstruction) \$3 M request (\$4 M total)
- CP, Monarch Improvements \$2.1 M request (\$3 M total)
- **DC**, C-470 Trail over Broadway Bike/Ped Bridge (preconstruction) \$600 K request (\$750 K total)
- P, Parker Road Corridor Plan Phase 2 (study) \$500 K request (\$750 K total)
- P, Parker Area Intersection Improvement Project \$4 M request (\$5 M total)
