## Background

- Process to revise the *DRCOG Committee Guidelines* began in June 2022, last updated in 2017
- Current structure and process
  - 2 Denver members and 2 specific alternates
  - Changes to TAC membership coordinated through DRCOG



# Background

Proposed structure and process:

- <u>3</u> members from the City and County of Denver
- Alternates will no longer be tied to specific members. (e.g., the "3<sup>rd</sup> alternate" is not directly tied to the "3<sup>rd</sup> member")
- Replacements for vacancies will be directly appointed by The Forum (rather than making a recommendation to DRCOG for appointment)
- Per the updated Committee Guidelines, local government TAC members shall be public works, transportation, or planning directors, managers, or other senior level staff.
