- The Denver Regional Council of Governments is designated by the State to receive and administer Older Americans Act (OAA) funds for the region as the Area Agency on Aging.
- The State Unit on Aging awards NSIP funds to the DRCOG Area Agency on Aging in proportion to the total number of previous year OAA meals served in the state.
- DRCOG receives these NSIP funds and distributes them to Volunteers of America, the region's only OAA funded nutrition provider.
- Neither DRCOG nor the State are aware of the exact number of dollars DRCOG will receive in 2017, however DRCOG anticipates receiving no less than \$500,000.
- By adopting this resolution, the Finance and Budget Committee is authorizing 2017 NSIP funds to be distributed to Volunteers of America.

#### **SUBJECT**

This action concerns DRCOG contracting with the Colorado Department of Transportation (CDOT) for two transit-related grants using Federal Transit Administration (FTA) funds.

### PROPOSED ACTION/RECOMMENDATIONS

Staff recommends authorizing the Executive Director to negotiate and execute contracts with CDOT for the FTA funds.

#### SUMMARY

In November of this year, CDOT asked DRCOG to submit proposals for two transit grants previously awarded to or under the purview of the Denver Regional Mobility and Access Council (DRMAC). The term of both grants is January 1, 2017 through December 31, 2017.

The first is a Veterans Transportation and Community Living Initiative (VTCLI) grant through FTA. The grant is intended to facilitate better coordination of transportation providers in the region through technology improvements to provide a seamless way for veterans and other vulnerable populations to access transportation information and services.

The total contract amount is \$620,000: \$496,000 in federal (FTA VTCLI funds) and \$124,000 (20 percent) in matching funds. DRCOG staff proposes to provide the matching funds using Older Americans Act (OAA) dollars, which is allowed under federal regulations. In addition to OAA funds, DRCOG staff will solicit private funds from organizations already familiar with this project to assist with match requirements. Staff will also explore other alternative funding sources.

The second grant involves the FTA 5310 program (Enhanced Mobility for Seniors and Individuals with Disabilities). Through coordinated efforts between Transportation Planning and Operations and Area Agency on Aging divisions at DRCOG, staff would use this funding to increase transportation mobility for the region's vulnerable populations using existing tools, staff expertise and expanding on current resources.

The total contract amount is \$200,000, with \$160,000 in FTA 5310 funds and \$40,000 (20 percent) in matching funds. As with the VTCLI grant, DRCOG staff propose to provide the matching funds using Older Americans Act (OAA) dollars. In this case, federal regulations specify that existing OAA expenditures can be used as a credit toward the FTA 5310 match, meaning that DRCOG would not have to provide \$40,000 in "additional" OAA funds, but rather could apply that amount already being used for transportation services towards the FTA 5310 grant.

DRCOG staff is asking the Finance and Budget Committee to authorize the Executive Director to negotiate and execute contracts with CDOT for the FTA funds described above.

WHEREAS, DRCOG, as the Metropolitan Planning Organization, is responsible for carrying out and maintaining the continuing comprehensive transportation planning process in the Denver Transportation Management Area; and					
WHEREAS, the Colorado Department of Transportation requested DRCOG submit proposals for continuing regional transit coordination, mobility management, and related activities to improve mobility options and services for veterans, older adults, and other vulnerable populations using FTA VTCLI and FTA 5310 grant funds for 2017; and					
WHEREAS, both grants require 20 percent matching funds, which DRCOG will provide for both grants using Older Americans Act/Older Coloradans Act funds and private funds; and					
WHEREAS, estimated federal grant amounts are \$496,000 (VTCLI) and \$160,000 (FTA 5310) and estimated DRCOG matching funds are \$124,000 (VTCLI) and \$40,000 (FTA 5310).					
NOW, THEREFORE, BE IT RESOLVED that the Executive Director is authorized to negotiate and execute contracts with the Colorado Department of Transportation for FTA VTCLI and FTA 5310 grant funds in the total amount not to exceed \$820,000 for the period January 1, 2017 to December 31, 2017.
