SUBJECT

 Review of previous and newly conducted transportation coordination studies including all recommendations and opportunities for collaboration. Information presented by both DRCOG (Chandra Matthews) and Denver Regional Mobility and Access Council (Angela Schreffler) staff.

PROPOSED ACTION/RECOMMENDATIONS

 Staff recommends comparing and contrasting the results of the two studies presented and providing guidance for AAA staff on how to move forward in improving the coordination and delivery of specialized transportation in the DRCOG region.

ACTION BY OTHERS

In December 2010 this committee along with the DRCOG Board of Directors
Administrative Committee approved implementing recommendations on ways to
improve the DRCOG AAA's process of providing Older Americans Act (OAA)
Transportation Services throughout the region. The recommendations, outlined in a
study conducted by BBC Research & Consulting, included working to create a
"centralized scheduling and dispatch center" that would better coordinate the
transportation service deliver in our region.

SUMMARY

- Since the above action, DRCOG staff has put efforts to implement the BBC study recommendations on hold in order to coordinate with the Denver Regional Mobility and Access Council (DRMAC) who was also moving toward coordinating specialized transit within the region and avoid duplication of effort.
- In July 2012, DRMAC opted to conduct its own study on how to best coordinate specialized transit services in the region and contracted with a consulting firm to provide recommendations designed to take into account funding outside of only OAA funds and inclusive of the full metro area (incorporating Boulder County).
- In March 2013, DRMAC's study was finalized and at this time there is a need to determine the next steps in transportation coordination – continue on to implement recommendations of the BBC study or continue working to partner with DRMAC.

PREVIOUS DISCUSSIONS/ACTIONS

 December 2010 – action by both the ACA and DRCOG Administrative Committee to implement recommendations of the BBC study.
