This year's event was originally scheduled for April 22 at Empower Field at Mile High. Due to COVID-19, the event was indefinitely postponed although we have a hold on the venue for Sept. 30, 2020. Directors were presented with several options including:

- Continuing as planned on Sept 30, 2020
- Exploring alternate formats
- Other date considerations
- Event cancellation with awardees honored in different ways

Directors discussed the importance of honoring the people, plans and projects that have made our region a great place to live. Options were narrowed down to proceeding as planned for September 30 or postponing the event until Spring 2021. The committee asked DRCOG staff bring back to the committee the obstacles, pros and cons of both options.

SUMMARY

Annually DRCOG hosts an awards celebration to honor the people, plans and projects that are moving Metro Vision forward and making our region a great place to live. This year's event was originally scheduled for April 22 at Empower Field at Mile High, then postponed indefinitely due to COVID-19, with a hold on the venue for a September date. Following our June discussion and requests, we'd like to discuss options for celebrating our region in 2021.

PREVIOUS DISCUSSIONS/ACTIONS

At the June 3 Performance and Engagement committee meeting staff presented format and timing options for the awards program. The majority of Performance and Engagement Committee members suggested DRCOG postpone the planned event until spring 2021, with largely the same format and venue, at Empower Field at Mile High. Additionally, staff was asked to explore options that included adding another slate of winners to our current awardees and combining them into one event or hosting a second event in fall 2021.

AWARDS CELEBRATION: DETAILS TO DATE

- This year's annual awards celebration was scheduled for April 22, 2020, at Empower Field at Mile High.
- In late March, all award winners, sponsors and attendees were informed the event was **indefinitely postponed**.
- DRCOG has a hold on Sept. 30, 2020, at Empower Field at Mile High in case a fall event is desirable.

AWARDS CELEBRATION: COVID-19 CONSIDERATIONS

- All out-of-pocket costs (not including staff time) are typically covered by corporate, nonprofit and member government sponsorships.
- Under Colorado's current Safer at Home and in the Vast, Great Outdoors phase, indoor gatherings of more than 100 people are prohibited. Six feet of distance must be maintained between attendees.
- The annual awards event typically attracts 400 to 500 guests. It is unclear when public gatherings of more than 100 people will be allowed.

COMMITTEE GUIDANCE FROM JUNE 3, 2020

- Maintain hold on Sept. 30, 2020, at Empower Field at Mile High until mid-July drop-deadline.
- Begin planning for a **spring 2021 event**.
- Proceed with catering and vendors as originally planned.
- Adapt event theme as necessary.
- Consider:
 - whether to honor a second slate of winners at the spring event
 - whether to hold a second event in fall 2021

AWARDS CELEBRATION: STAFF PROPOSAL

- Empower Field at Mile High has agreed to hold April 28, 2021, for a rescheduled awards celebration.
 - Staff recommends honoring only the slate of winners selected for 2020 at the spring 2021 event.
 - Metro Vision, Distinguished Service and Way to Go award winners have been notified they've won. Only the John V. Christensen Memorial Award winner does not know they have been selected.
 - These recipients are worthy of due recognition.
 - Honoring an additional slate of winners would significantly extend the length of the program.

AWARDS CELEBRATION: STAFF PROPOSAL (cont.)

- Staff recommends holding only a spring 2021 event.
- Fundraising for two 2021 events may be challenging.
 - Partners expect and budget for annual requests for sponsorship.
 - Many organizations may still be recovering from economic disruption next spring.
- Planning and executing the awards celebration takes significant staff effort over many months.
- Nominations for the 2022 awards celebration would open, as typical in fall 2021.
