"New" Area of Emphasis

Suggested by Board and Stakeholders

♦ Community Resiliency

- Builds on Board initiated Metro Vision 2035 Plan Amendment ("wildfire policy")
- 2013 Board workshop input: Resilient infrastructure and communities should be an area of emphasis in the plan update
- Community resiliency, hazard mitigation and disaster recovery were consistent themes heard from numerous stakeholders
- Focus (as drafted): limit conflicts, integrated planning, coordination and strategic open space planning
 - Also integrated into other elements (see memo for examples)



2015 Board Workshop

What does it mean to be a resilient region - is resiliency an appropriate overarching theme?

- We want to be a resilient region, should this be our lens?
- ◆ Currently a hot topic could be a framing issue
- ◆ Should be included safeguarding for future generations





2015 Board Workshop (cont.)

What does it mean to be a resilient region - is resiliency an appropriate overarching theme?

- ◆ Bouncing back even stronger after disruptions
 - Chronic challenges can make bouncing back difficult
- ♦ It's nothing new important concept in our place in the world
- ◆ Make the term our own





(Mar. 2015 Draft)

- ◆ Draft plan attempts to infuse resilience throughout the plan – primary discussion in A Safe and Resilient Built and Natural Environment
- ◆ Hazard mitigation and resiliency identified in introduction (Building on Successes...) as existing and emerging issue
- ◆ Informal definition: "...ability to respond and recover from events..." (Pg. 43)

Outcome 11: Reduced risk and effects from natural hazards

- ◆ Objective 11.1(a): Enhance community resiliency
 - Limit expansion of the wildland-urban interface
 - Promote integrated planning and decision making
 - Foster interagency coordination
 - Prioritize open space protection in high-risk areas



(Mar. 2015 Draft)

Resiliency linkages across plan issues (examples):

- Demographic changes (particularly aging of the population)
- Developing and maintaining a multimodal system
- ◆ A safe, dependable and actively managed transportation system
- ◆ Managing the region's urban expansion



(Mar. 2015 Draft)

Resiliency linkages across plan issues (cont.):

- Resident access to a range of transportation, employment, housing, education, cultural, and recreational opportunities
- Quality of life amenities that are key to attracting and retaining the region's workforce
- ◆ Protecting natural systems (air, water and land)





Measuring Resiliency

(Mar. 2015 Draft)

- ◆ Objective 11.1(a): Enhance community resiliency
 - Amount of high risk areas protected as open space or park
- ◆ Other resiliency related measures (a few examples):
 - Share of population with good transit-job accessibility (all and low-income)
 - Number of air quality violation days
 - Infrastructure ratings (bridge ratings, pavement condition, etc.)
 - Population living in areas with low food access
