Tim Mauck was elected to the Clear Creek Board of County Commissioners in 2010 and reelected in 2014. As a commissioner, he has focused on economic development, enhancing Clear Creek's recreation and tourism industries and bringing about sensible development strategies to improve transportation along the Interstate 70 Mountain Corridor. Notable achievements include revitalization of the Clear Creek Tourism Bureau, crafting a multiyear development agreement with the Colorado Department of Transportation for I-70, supporting more than \$6 million for constructing a recreational path through the county and funding an affordable housing program in Clear Creek County.
