Agencies Reviewed

- Houston Metro
- Dallas Area Rapid Transit (DART)
- Metro Atlanta Rapid Transit Authority (MARTA)
- King County Metro Transit
- Massachusetts Bay Transit Authority (MBTA)



Houston Metro

- Metro Q Fare Card
 - Reloadable card with online portal to charge and view balance
 - 5 free trips for every 50
 - Zoned fares, pricing varies
- Metro Q Mobile Ticketing
 - Purchased through app, accepted on bus, BRT, rail, and park and ride
- Other pass options: Metro Day Pass and Metro Money
 - Metro Day Pass is more cost effective for rider who use transit at least 3 times daily

- GoPass Tap Card and App
 - A variety of fare and pass options can be loaded on the Tap Card and App including Day and AM/PM or Midday Passes and monthly passes
 - Monthly passes cost \$96 for Local, \$192 for Regional
- Other pass programs include annual passes (\$960 Local) and a variety of programs for specific groups



MARTA

- Breeze Card
 - Can load multiday, multi-trip, or monthly passes onto the card for unlimited day travel, or individual rides
 - 30-day pass: \$95
 - 20-trip pass: \$42.50
 - Transfers to other regional transit systems
- Other options: Atlanta Streetcar Day Pass





King County Metro Transit

ORCA

- Load cash or day or monthly passes onto ORCA card to pay for fares in the Puget Sound region
- Fares for adult, youth, low-income, seniors and disability or Medicare
- Can be used across regional transit agencies with time-limited free transfers
- Other options: Transit GO Ticket (mobile app)



- CharlieCard
 - Can be loaded with cash or passes to pay fares
 - 1 day, multiday, and monthly passes
 - Monthly LinkPass (includes subway): \$90
 - Monthly Local Bus Pass: \$55
 - Commuter Rail Passes
 - Zoned fares, prices vary
- Other options: CharlieTicket, mTicket (mobile), or cash
