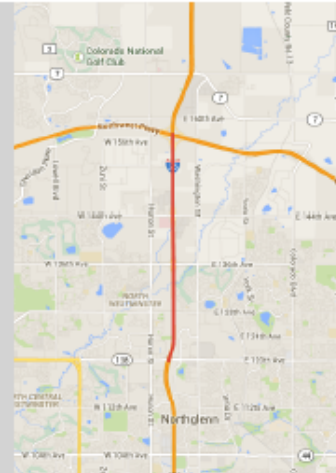

Project will resurface the entire stretch, add traffic management, sound wall, and tolling/ITS equipment.
