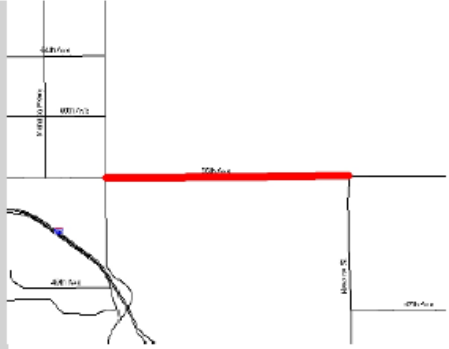

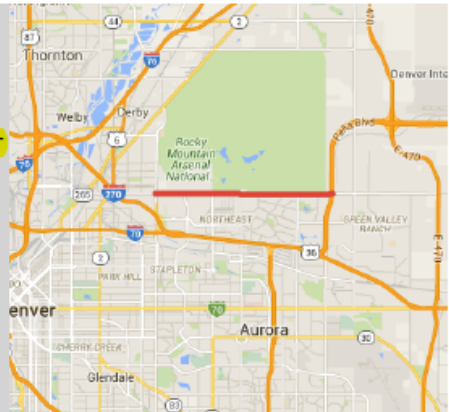
Funds in the 2016-2021 TIP will be expended to:

- (B) Conduct a separate NEPA environmental clearance, as well as final engineering, for operational improvements to 56th Avenue across the Pena Boulevard Corridor.

- B) Widen 56th Avenue from 2 to 6 lanes between Quebec Street and Havana Street.
