Lochbuie and Castle Pines: Welcome to DRCOG!

DRCOG is pleased to welcome two new member governments to its roster. Castle Pines (my hometown) joined in March and Lochbuie joined in July.

Castle Pines is represented by Tera Radloff as director and Geoff Blue as alternate. Incorporated on February 12, 2008, Castle Pines is a city of about 10,000 residents located approximately 20 miles south of Denver in Douglas County, Colorado.

Lochbuie is represented by Jacob Lofgren as director and Larry Strock as alternate. Incorporated in 1974, the Town of Lochbuie has approximately 5,000 residents and is located approximately 15 miles northeast of Denver in both Weld and Adams counties.

Transportation Improvement Program spotlight: City of Thornton



Late last year, the City of Thornton completed a Claude Court realignment project to provide multimodal access to RTD's Eastlake at 124th Station. The project included on-street bike lanes and a 10-foot-wide concrete trail adjacent to the station.

For the \$952,000 project, DRCOG provided 80 percent of funding through the Surface Transportation Program-Metro. Thornton provided 20 percent of funding.

The project complements two other projects that extend multimodal access north to 128th Avenue:

- a Thornton-funded capital improvement project to continue the developed roadway north of the station
- a TIP-funded project to construct the 10-foot trail north of the station



Following adoption of the Metro Vision update in January, DRCOG staff developed a <u>website</u> that represents not only the Board-approved document, but also:

- the region's <u>history</u> of regional collaboration
- how <u>local communities</u> are contributing to the region's aspirational vision of its future
- events related to regional planning and development
- visualizations of progress toward <u>performance measures</u> identified in Metro Vision

The site went live Aug. 1. Please let me know what you think of it!

DRCOG expands Colorado Choice Transition services

With the approval of the Finance and Budget Committee at its July meeting, DRCOG will expand its Colorado Choice Transition program to provide fee-for-service options counseling estimated at \$202,500 under a contract with the Colorado Office of Health Care Policy and Financing.

Area Agency on Aging options counselors help ensure a successful transition, which averages six months per client. Services include helping clients in nursing homes return to their communities by facilitating housing and community-based services.


