The Area Agency on Aging receives federal Older Americans Act Title III funds and State Funding for Senior Services funds to support community service programs that benefit adults 60 and older. DRCOG is currently seeking proposals for the next two-year grant cycle, beginning July 1, 2019. The application period closes at 5 p.m. tomorrow, Jan. 11.

Way to Go is providing congestion mitigation services on the I-25 South Gap project. The 18-mile stretch of Interstate 25 known as "The Gap" runs from south of Castle Rock to Monument. Way to Go offers personalized solutions to commuters who drive along the construction corridor. From helping commuters explore vanpool to Bustang to carpool, the I-25 My Way team is reducing stress around construction.

The Colorado Department of Transportation is improving safety through "the Gap" by providing wider shoulders for emergency pull-off and response, five new wildlife crossings, deer fencing, replacement and repair of four bridges, new overlay to existing pavement and improved truck access near Monument Hill.
