

USE IDEAS: TDM TOOLKIT


Some ideas for using the toolkit:

- Use for CDOT PD 1601 TDM requirements.
- Use to help a developer understand the range of potential TDM solutions based on their context.
- Explain to decision makers what TDM is, and the wide range of strategies that can be implemented.

USE IDEAS: TDM TOOLKIT

- Help public agency staff produce TDM strategy ideas for different locations within the Denver region.
- Identify TDM solutions for specific audiences that require additional transportation support.
- Understand how equity plays a role in different TDM strategies.
