### Review Corridor-Wide Opportunities and Challenges

Goal: Review the Corridor-Wide Opportunities and Challenges to determine if they are sufficiently complete to inform the development of draft Vision and Goals.

### Refine Corridor Vision and Goals

Goal: The group will refine the Gold Corridor Vision and Goals, based on a review of the Corridor-Wide Opportunities and Challenges and input from the Stakeholder Committee. Questions may include:

- What impact are you trying to achieve? What specific needs are you trying to address?
- Are you missing any key priorities?
- If progress is made on these goals in the next five years, do you feel like the Gold CWG would be successful?

### Begin the Process for Identifying and Selecting Recommended Implementation Strategies

Goal: The group will discuss the process for identifying and selecting Recommended Implementation Strategies to achieve identified goals, leverage opportunities and overcome challenges. The recommended process is:

1. Reconnecting America will develop and share a list of potential implementation strategies.
2. CWG members will provide feedback on which recommendations are priorities, share additional ideas, etc.
3. CWG members will identify criteria and a selection process for prioritizing a list of final Recommended Implementation Strategies, including a consideration of resources required for designing and implementing the final strategies.
4. CWG members will conduct the selection process to identify final Recommended Implementation Strategies



5. CWG members will develop a three to five year strategy for implementing Recommended Implementation Strategies

*Resources will be available to develop baseline information to inform, refine and conduct Recommended Implementation Strategies. However, the amount of those resources has not been determined and is dependent on the results of current discussions with HUD.*

### **Review the Process for Identifying and Selecting a Catalytic Site**

Goal: Paul Aldretti will present information about the goals for Catalytic Sites and the baseline criteria that all potential sites must meet. CWG members will provide feedback on the criteria for evaluating potential sites and discuss the process for identifying and selecting a Catalytic Site in the corridor.

*Resources will be available for pre-development planning at the Catalytic Site. However, the amount of those resources has not been determined and is dependent on the results of current discussions with HUD.*
