11:45 Select ArapCo Forum Representative on RTD's Sub-Regional Council Working Group As a part of RTD's response to the Accountability Committee's Recommendations (July 2021), RTD is forming a Sub- Regional Service Council Working Group (SRCWG).

ArapCo Forum is to designate a single staff representative to participate in the RTD Working Group.

Note that this Working Group is **NOT** a sub-regional service council and will have a limited scope of responsibility and time commitment. The Working Group will include participation from other Sub-Regional Transportation Forums and entities representing RTD's customers and will be facilitated by RTD staff.

Scope: The SRCWG will assist RTD in developing recommendations for Sub-Regional service councils by:

- considering the purpose, role and operation of sub-regional service councils,
- identifying the membership of subarea service councils, including assuring representation from local jurisdictions, transit advocates and RTD customers; and
- evaluating the two council boundary concepts put forth by the Accountability
 Committee, which include a county-based model and a travel shed-based model.
- Note: RTD will continue to evaluate ways to enhance the existing stakeholder listening session model to ensure that social equity remains at the forefront of service discussions and decisions with Title VI as a basis.

- Conduct kick-off meeting of working group February 9, 2022 at 1:30PM
- Working group meetings February March 2022

- Develop recommendations for purpose, role, operation, membership and boundaries of sub-regional service councils **April 2022**
